#### LETTER FROM THE CHIEF

It is my honor and privilege to present the 2022 Blissfield Police Department Annual Report. Within the pages of this report, you will find statistics and descriptions which measure and document the activity of the department over the course of the year. In reviewing this report, please keep in mind that it not only consists of numbers and percentages, but it also represents the dedication and commitment of the police department's employees who make our Village a safe place to live, work, enjoy leisure time and raise a family.

2022 saw some return to normalcy for our community as we all recovered from the impacts of the global pandemic. Traffic increased to levels more in-line with pre-pandemic levels as people returned to work. There were also increases in criminal activity that were consistent with pre-pandemic levels as well.

Officer Rhoni Khouri left the department after serving here for three years. Officer Dave Luce came on early in 2022 as a part-time officer and finished the year in the capacity of the newly created position of School Resource Officer.

The two vacancies from patrol positions were in addition to the loss of a part-time equivalent position when Officer Luce was hired part-time to fill the full-time opening that was the result of the departure of Officer Tyler Raburn in 2021. Recruitment has been challenging as we compete with hundreds of other law enforcement agencies around the State of Michigan for qualified applicants. There is a continuing shortage of individuals seeking careers in law enforcement. While we seek the right candidates to work in a small-town atmosphere, we must compete with other agencies that are offering significantly higher salary and benefit packages.

On behalf of the Blissfield Police Department, I want to thank the entire community for their ongoing support of their police department. It is this community support that allows us to be a professional and proactive law enforcement agency. Community Policing continues to be a high priority for the department.

I am extremely proud of the dedicated members of the Blissfield Police Department who will continue to carry us into the future. I would also like to ask that if you see an officer or other Village employee doing a great job, please let us know. We want to recognize those officers and civilian staff members for their hard work, dedication and efforts.



It has been my honor to serve as the Chief of Police for the Village of Blissfield. Thank you for the continued trust and support you have instilled in the department. The department will continue to provide exceptional service to our citizens with a commitment to our core values. Your support goes neither unnoticed nor unappreciated.

#### AGREEMENTS AND CONTRACTS

There were no new or renewals of agreements or contracts during the year.

#### **EMERGENCY PREPAREDNESS AND RESPONSE**

The Blissfield Police Department continues to plan and train for responding to any critical incidents that might occur, including natural occurrences such as storms and flooding and criminal acts such as active shooters. During 2022, we experienced a sustained manpower shortage. The law enforcement profession throughout the State of Michigan has become very competitive with regards to agencies attracting and retaining personnel. We continued to focus on providing the best possible services. In light of the number of school shootings within the state and around the country, the safety and security of our schools remained a top priority and concern. Through a coordinated effort with the Blissfield Community Schools, we were able to create a full-time School Resource Officer (SRO). Police Officer David Luce was assigned as our SRO and assumed his role shortly after the school year started this past Fall.

We continue to train with the Blissfield Township Fire Department (BTFD) and the Madison Township Fire Department with a multi-pronged objective to continue preparations for any critical incidents that might result in mass casualty events.

The State of Michigan has also initiated new statutory requirements for Active Threat Response Training to be implemented through the Michigan Coalition on Law Enforcement Standards (MCOLES.) MCOLES is in the process of establishing the training standards and we are working through our training consortium to obtain that training once the courses are established. Most, if not all, of the standards have already been achieved through various trainings attended by our officers prior to the statute being enacted. However, we will continue to train in compliance, and in addition, to the statutory requirements.



### SCHOOL RESOURCE OFFICER

In October the Village of Blissfield and the Blissfield School District embarked on a partnership to provide a School Resource Officer for Blissfield Community Schools. Blissfield police officer Dave Luce was selected to fill this position. Officer Luce attended a 40-hour Basic School Resource Officer training in Indianapolis, Indiana.

Since the onset of this new position, the school administration, staff, and students have all been very supportive of Officer Luce within the school system. On an average day, Officer Luce will have a presence in the elementary, middle and high schools throughout his shift.

The school resource officer has been a valuable asset for both Blissfield Community Schools and the Blissfield Police Department. Though this position is still in its early stages, it continues to grow into a vital part of the community and a vital asset to both the school district and the police department.

#### **NARCOTICS**

The Blissfield Police Department continues to work with the Lenawee County RHINO Unit on detecting any trafficking activity within the Village limits.

### **COMMUNITY ALERT AND ADVISORY SYSTEM**

The Blissfield Police Department utilizes the RAVE Alert System offered through the Lenawee County Sheriffs Department. While use of that system is restricted to established criteria, there is no cost to the Village to use the system and alerts can be sent to all telecommunication devices within the geographical area. For incidents and situations that do not meet the criteria for a RAVE alert (such as snow emergency declarations) the Police Chief continues to issue press releases directly to the media as well as for publication on the Village social media pages.

#### **OFFICER TRAINING**

Law Enforcement agencies in Lenawee and Jackson Counties are members of the Southern Michigan Criminal Justice Training Consortium. The Blissfield Police Department receives many hours of officer training at minimal cost. In accordance with the agreement, BPD normally contributes half of the Public Act 302 training funds that we received from the State of Michigan to support the training activities. Common training includes:

- Precision Driving School
- Defensive Training for all officers,
- Radar/LIDAR (speed measurement) recertification and certification.
- Taser recertification for all officers.
- Emergency Vehicle Operation.
- Narcan Administration Training.
- Standardized Field Sobriety Testing Training.



#### Additional Training:

BPD participates regularly in a wide spectrum of training topics, including quarterly firearms qualification and training, Active Shooter Response Training, Computer Training, Legal Update, Interviews and Interrogations, and Counter-Terrorism.

#### **FIREARMS TRAINING:**

Officers are expected to constantly keep up with professional skills and changing requirements. All members participated in quarterly weapons training and/or qualification. The BPD conducts regular firearms training, both in daylight and darkness. Firearms training now includes the Tactical Patrol Rifle, handgun, and shotgun. Additionally, BPD officers may participate in tactical training with other agencies for readiness preparedness and response for active threat situations.

#### **POLICY REVISIONS**

Department policies are reviewed and updated when new standards are determined to be best practice or to comply with new legal requirements. The policies that were updated in 2022 are as follows:

#### Safety City

The annual Safety City was held August 8-12, 2022. This is the second year that the Blissfield School District has organized the event. Safety City continues to provide an enjoyable environment for new students to learn about their community.

The children get to drive battery powered cars, pedal bikes or walk as pedestrians on a painted traffic area. There was a guest speaker each day to talk about bike safety, poison safety, fire safety, electrical or water safety and bus safety. ## **CALLS FOR SERVICE**

Calls for Service include all 911 calls, calls initiated by the patrol officer, calls for backup, and calls for mutual aid. Calls for Service do not necessarily equate to an actual criminal offense having occurred. Calls for Service simply characterizes the nature of the call. If more than one officer responded to an incident, such as a traffic crash, then a separate call is logged for each responding officer. Actual criminal offenses that occurred are reported separately.

### **REPORTED CRIMINAL OFFENSES**

REPORTED CRIMINAL OFFENSES are the confirmed reported crimes that occurred in the Village. The total number of reported crimes <u>increased 3.4%</u> from 2021 to 2022.

- **Property crimes** (Larcenies, Breaking and Entering, property damage) increased from 34 in 2021 to 39 in 2022 a 14% increase.
- **Violent crimes** (Assaults, kidnapping, sex crimes, stalking, weapons offenses, obstructing police) increased 16 in 2021 to 22 in 2022 <u>a 27% decrease.</u>



- **Driving offenses** (Suspended license, uninsured motor vehicle, etc. excluding OWI offenses) decreased from 37 in 2021 to 23 in 2022 a 37% decrease.
- Operating while intoxicated/impaired by Alcohol / Narcotics 8 in 2021 and 8 in 2022 no change.
- Narcotics offenses increased from 1 in 2021 to 2 in 2022– a 100% decrease.
