ORDINANCE NO. 2023-04c

AN ORDINANCE TO AMEND CHAPTER 5 COMPENSATION FOR VILLAGE OFFICIALS OF THE VILLAGE CODE FOR THE VILLAGE OF BLISSFIELD.

WHEREAS, the Village Council has established council goals and objectives with one of them being to update ordinances; and

WHEREAS, the following ordinance amendments would clean up the ordinances; and

WHEREAS, the following ordinance amendments would place like codes within one chapter making it easier to follow for both staff and the general public; and

NOW, THEREFORE, be it ordained by the governing body of the Village of Blissfield, Michigan that Chapter 5 be adopted following passage and publication to adopt hereinafter specified:

5.00 COMPENSATION FOR VILLAGE OFFICIALS AND EMPLOYEES

5.001 Village President.

Sec. 1. The Village President shall receive Four Thousand Nine Hundred Twenty Dollars (\$4,920.00) per year paid quarterly to take effect October 1, 2019.

5.002 Village Trustee.

Sec. 2. Each Village Trustee shall receive Three Thousand Four Hundred Dollars (\$3,400.00) per year paid quarterly to take effect October 1, 2019.

5.003 Village Clerk.

Sec. 3. The salary for the Village Clerk shall be as follows:

1. As established by the Wage Scale adopted annually by Resolution by Village Council.

5.004 Village Treasurer.

Sec. 4. The salary for the Village Treasurer shall be as follows:

1. As established by the Wage Scale adopted annually by Resolution by Village Council.

5.005 Reserved.

Editor's note— An amendment adopted June 11, 2001, canceled and deleted 5.005, which pertained to compensation of the Village Assessor and derived from Ch. No. 11000, § 6, and amendments of Dec. 19, 1977, and June 12, 1995.

5.006 REPEAL.

5.007 Village Attorney.

Sec. 7. The Village Attorney shall receive payment pursuant to attorney-village agreement as approved by Village Council.

5.008 Compensation for Building Inspector.

Sec. 8 The building inspector for the Village of Blissfield shall be paid as follows:

- 1. The base fee shall be \$10.00 per permit issued.
- 2. Each inspection shall be \$41.50.

- 3. Certificate of Occupancy fee shall be \$10.00.
- 4. Mileage shall be paid based on the rate established from time to time by the U.S. General Services Administration.
- 5. Court time, work for the Village, and additional meetings shall be paid at the rate of \$40.00 per hour.
- 6. Any inspection lasting more than one hour shall be billed additionally at the rate of \$40.00 per hour.
- 7. A pro-rate share, based on the number of municipalities the Building Inspector is employed by, of all continuing education units (CEU) expenses to be paid semi-annually.

5.009 Compensation for Mechanical/Plumbing Inspector.

Sec. 09. The Mechanical/Plumbing Inspector for the Village of Blissfield shall be paid as follows:

- 1. The Mechanical/Plumbing Inspector for the Village of Blissfield shall be paid Eighty (80) percent of all permit fees.
- 2. A pro-rate share, based on the number of municipalities the mechanical/plumbing inspector is employed by, of all continuing education units (CEU) expenses to be paid semi-annually.

5.010 Compensation for Electrical Inspector.

Sec. 10. The Electrical Inspector for the Village of Blissfield shall be paid as follows:

- 1. The Electrical Inspector shall be paid the sum of One Thousand Three Hundred Twenty Dollars (\$1,320.00) per year payable semi-annually on April 1 and October 1 of each year.
- 2. In addition, the Electrical Inspector shall receive Eighty (80) percent of all permit fees. In the event a permit is issued, and no fee is charged, the Electrical Inspector shall be paid the sum of Six Dollars (\$6.00).

5.011 Repeal; Effective Date.

Sec. 11. All ordinances and resolutions inconsistent with this Ordinance are hereby repealed. This ordinance shall be effective upon publication.
